Summer Season April 1 to October 31 Winter Season November 1 to March 30

Rates as shown same for all harbor locations

Summer Slip Rates:

Rate is \$59/foot of slip length Additional \$6.25/foot of slip length for Harbor Maintenance fund

Club House Fee:

Includes access code and use of clubhouse, showers, kitchen, etc. \$135

Common Fee:

Covers common area utilities, pump out equipment and insurance \$120

Membership Dues:

Regular (voting) Members \$100 Associate Members \$100 Social Members \$75

Winter Storage:

Rates are \$32 X LOA. Includes lift, wash bottom, blocking, spring launch

Summer Transient Slips:

Transient slips are \$1.00 per ft. per day Includes electrical service & parking

Boat Trailer Storage:

\$125 per season

Club Membership:

Regular (voting) membership requires 1 year presence in the harbor and \$1,500 initiation fee. (Additional discounts apply with membership)

Discounts:

Annual (summer & winter) discount \$50 Prompt Pay (March 1) discount \$50
