Staff and general update:

Dockwa system usage/ contracts and payment: Contract for winter storage went out today and we already had twelve sign and pay. Some 15 people did not get the inspection discount, but that was because they were never billed and never paid it in the spring. We're all-in with Dockwa, but we are still working to ramp up all of the related reporting and actions that will assist in office functions.

Looking to find another accounting firm as our current firm is very slow with delivering responses in a timely manner.

Dahlgren dock pump-out extension is complete with the exception of removing the old plumbing. That will be removed next year. LH Gas lines status: We have almost all the parts, but there are key parts that have not been delivered by the distributor/manufacturer that takes five weeks to make. That will lately not allow us to get this done before the real heating season begins shortly.

Boats moving in LH: Some boats have moved so they can get to areas with deeper water. A couple boats are coming out for winter. One has planned to go to another marina over this winter. Some boats are coming out because they will not be living on their boat during the winter and have chosen to store their boat on land.

Gate E Miller dock entrance cover status: Cover is going to be done by Brian after haul-out activities are done. He'll be working for a few weeks after haul-out to get work done to finish some accumulated smaller jobs/ projects that can be done anytime. Fall Haul-out planning: Members should go out with a sign-up date for haul-out. The last boat out is 3pm on any day. All boats should be pumped out before the day they are to be hauled. Looking to hire someone to bottom wash boats as their pulled.

Harbor Maintenance:

Current and future plans in process.

Sample testing came back as Level 1, which is where we really hoped it to be.

We have a plan to move material as where to store it. Some activity/ motion to purchase equipment will be discussed this tonight with further stages discussed at our next board meeting September 28th.

Buy the Piranha dredge, hose, spare parts and accessories for around \$20k.

Dino 6 dredge is more of a platform that we would rent for a month for \$15k plus cost to have it shipped in.

Cost for silt bags, lagoon, etc. for on-land storage needs to be further spec'd and quantified.

Motion to purchase Piranha dredge, hose, spare parts and accessories for around \$21k as quoted on June 22nd. Additionally to alow expenses of up to \$5k for additional tubing and geo-supplies from local suppliers.

Quote from Piranha dredges is still valid from 6/22/2020 in the amount of \$20,799.68.
